2.2 Conclusions and further actions

The presentations were followed by a discussion in which participants offered their comments and experiences on the importance of the mentoring program. Participants expressed their satisfaction with the content of the first workshop and with the group as they could share their experiences with mentoring and working in different working environments. The discussion about mentoring gave them different perspectives on the process and involved parties. They saw more importance and value in mentoring than before.

We have set tentative dates for mentor training. All trainings will be held in the morning, which according to the results of the survey is most convenient for the participants. Invitations to the mentoring program will be sent via email to female forest professionals and forest owners. In order to reach as many interested people as possible, including forestry students and young professionals, the invitation will also be published on social media.

Before the end of the project, we are planning a New Year's meeting, where we will also officially conclude the training of the mentors.

In addition to the planned mentoring workshops, the mentors will also meet at the final conference of the Fem4Forest project, which will take place on November 17, 2022, in Bled, Slovenia.

The idea is that the mentors will meet at least once a year to stay in touch and share their experiences. If possible, we will organize at least one training for mentor women per year.

3. New forms of cooperation

Forest walks and establishment **of Association "Women in Forestry"** were selected as new forms of cooperation to be implemented in Slovenia in T4 – as pilot action.

3.1 National Report

Please describe the technical and organizational background of your measures:

In Slovenia, as in many other countries, the forestry sector is still a male domain. However, it should be pointed out, that women own 40% of Slovenia's forests. Additionally, more and more women are becoming actively involved in the sector as forestry professionals. So the situation is slowly changing towards more and more women in the traditionally male-dominated sector, bringing different perspectives and ways of working to the sector. Women also face different challenges than men. Therefore, when selecting the pilot actions, we took into account the fact that both informal and formal gatherings to exchange experiences and opinions would facilitate women's active participation in the forestry sector.

Activity 1		
Content (short description)	The 1 st Forest walk took place at one of the most forested area in Slovenia, Pohorje. The walk started with the introduction on Fem4Forest project and the main aim of the walk by Nike Krajnc (project leader) and was followed by presentation of forest walks by Dagmar Karisch – Gierer (PP FAST Pichl). During the 1 hour walk to the protected lake and back we stopped several times and talked about several topics: establishment of association of women in forest sector in Slovenia, how to organize a forest walk, why forest walks are important, who can organize forest walks, how to define the topics of forest walks and others. The walk was concluded with lively discussion and lunch in front of the Ribniška hut.

Remarks	The idea for establishment of association of women in forestry in Slovenia was discussed on several occasions – at roundtables (T1 and T2) and also at the first meeting of mentors.

3.2 Feedback on implemented cooperation activities

After the three forest walks held so far, we can say that this type of gathering has filled a gap that was clearly perceived by women working in forestry. We have received only positive feedback from the women participants. The women forest owners talk openly about their experiences with the forest administration and forest contractors. They ask questions about issues that concern them and seek information on how to deal with forest contractors and forest visitors, for example.

The high number of participants also indicates satisfaction with the forest walks. Some of the women now attend the forest walks regularly, and new women join depending on the venue. Our goal is to reach as many women as possible in forestry sector, so the locations of the forest walks throughout Slovenia are selected with this in mind

At each forest walk, we encourage participants to name the topics they are interested in. So far we have two more agreed topics for forest walks on the list. One will be conducted by the owner of a large forest property in her own forest near Ljubljana, and the main topic will be fir tree management. The second planned walk will take place in the Štajerska region. It will also be led by the owner of a large forest estate and will deal with the topic of game damage.

4. Conclusions and future activities

Mentoring program:

The mentoring program was initially received with some skepticism, but nevertheless we received 13 applications for the international training of mentors prepared by NOWA in April-June 2022. The mentors who were selected for this mentoring program brought knowledge and new energy. We had a first meeting with potential mentors at the end of August. We decided to invite only women to this first round of training. We were pleasantly surprised by the high number of women who signed up for the mentoring program. We have 25 registrations for the training. We decided to hold 3 training sessions and an additional meeting in December. The program of training is nearly the some as at international training. We decided to have an external expert for training about communication. This training will take place at the end of October and beginning of November.

We plan to keep this group of women mentors active with annual meetings and training. We are also thinking of organizing a similar training for a new group of mentors (mixed group of women and men) if there is interest next year.

Forest walks:

The idea of forest walks was presented by an Austrian expert (Dagmar Karisch-Gierer) with excellent experience in organizing this kind of gathering. We believe that this positive example and the positive energy at the beginning of our forest walks gave us a positive "push", which can be seen in the number of participants in these walks. We have received only positive feedback and believe that this is the right way to bring together experts, forest owners and others interested in forestry. We have organized 3 forest walks and already have plans for the next 2.

One of the forest walks was led by a man, which is not usually the case in Austria. But from this experience we can say that this is also a good way to bring women and men together and discuss common problems in a relaxed environment. In any case, we plan to keep the forest walks in the coming years, and we believe that this is a new form of cooperation that will prevail in the long run.
